



Rules and Regulations: CAA Saskatchewan

\$1,000 Sobeys Gift Card Contest

CONTEST PERIOD: The Contest begins at **12:00 a.m. CST on August 22, 2026**, and ends at **11:59 p.m. CST on September 12, 2026** (the "Contest Period").

1. ELIGIBILITY

To enter and be eligible to win, an entrant must:

- Be a legal resident of Saskatchewan, be a CAA Saskatchewan Member in good standing (membership must be valid throughout the Contest Period and at the time the prize is awarded), and have reached the age of majority on the date they entered the Contest.
- Exclusions: CAA Saskatchewan employees, affiliates, and their immediate family members are not eligible to enter.

2. HOW TO ENTER

- **Purchase Entry Method:** During the Contest Period, eligible CAA Saskatchewan Members who purchase or reload a Sobeys Gift Card valued at \$100 CAD or more through the **CAA Gift Card Store at caagiftcards.com** will automatically receive one (1) entry into the Contest for each qualifying transaction. Purchases made through any other retailer, website, or channel are not eligible for entry into the Contest. Valid for Sobeys eCards and physical gift cards purchased through the CAA Gift Card Store. Physical gift cards purchased through a CAA Saskatchewan Store are not eligible. Sobeys liquor gift cards are excluded.
- Each qualifying purchase or reload of \$100 CAD or more constitutes one (1) entry. There is no limit to the number of entries an eligible member may receive during the Contest Period; however, an entrant may only win one (1) prize.
- **No Purchase Necessary Entry Method:** To enter without making a purchase, hand-print your full name, active CAA Saskatchewan membership number, complete mailing address, daytime telephone number, and email address on a plain piece of paper, insert it into a stamped envelope, and mail it to:

- Entries exist per member, not household.

3. THE PRIZE

- **One (1) prize** is available to be won, consisting of Sobeys grocery gift cards with a total approximate retail value of **\$1,000 CAD**.
- **The odds of winning depend on the total number of eligible entries received during the Contest Period.** The prize must be accepted as awarded and is not transferable, assignable, or convertible to cash.
- Gift card prize does not qualify for bonus 5% CAA Dollars earnings.
- **Prize Substitution:** If the advertised prize cannot be awarded for any reason, CAA Saskatchewan reserves the right, in its sole discretion, to substitute the prize with a prize of equal or greater value.

4. WINNER SELECTION & NOTIFICATION

- **Draw Date:** A random draw will be conducted on or about September 21, 2026, from all eligible entries received during the Contest Period.
- **Notification:** The selected entrant will be contacted via email. If the selected entrant cannot be reached or does not respond within five (5) business days, they will be disqualified and an alternate winner will be selected.
- **Prize Requirements:** Before being declared a winner, the selected entrant must correctly answer, without assistance of any kind, a time-limited mathematical skill-testing question and sign and return a Prize Acknowledgment and Release Form. Failure to comply with these requirements will result in disqualification and selection of an alternate winner.
