

Where in the World Contest – Summer 2026 Issue Official Contest Rules

The Where in the World Contest (the “Contest”) is sponsored and administered by CAA Saskatchewan (the “Contest Administrator”).

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY AGREEMENT MAY BE REQUIRED.

1) CONTEST PERIOD: The Contest begins at 11:00 a.m. Saskatchewan Time (Central Standard Time) on **May 26, 2026**, and ends at 11:59 p.m. Saskatchewan Time (Central Standard Time) on **August 7, 2026**. This time is the “Contest Period.”

2) ELIGIBILITY: The Contest is open only to current CAA Saskatchewan Members who are at least 18 years old as of the Contest start date and are residents of Saskatchewan. Employees of the Contest Administrator, its participating retailers or partners, affiliates, subsidiaries, distributors, sales representatives, advertising and promotion agencies, agents, sponsors, and contractors are not eligible to enter or win. Immediate family members of these individuals (parents, children, siblings, and spouses), and anyone living in the same household, are also not eligible.

3) HOW TO ENTER: To enter, eligible participants must complete the following step during the Contest Period:

- Email your location guess to caa.magazine@caask.ca.

Limit of one (1) entry per member. Each eligible email submission counts as one entry. Entries become the property of the Contest Administrator and will not be returned. Participants who do not follow these rules, provide the required information, or follow Contest instructions may be disqualified.

4) WINNER SELECTION AND NOTIFICATION: After the Contest Period ends, one (1) potential winner will be selected by random draw from all eligible entries received during the Contest Period.

5) PRIZE: One (1) winner will receive one Summer Prize Pack courtesy of CAA Insurance. The prize includes the following items, with an approximate total retail value of **\$193.60**:

6) ADDITIONAL PRIZE AND CONTEST TERMS:

• Prizes are non-transferable and cannot be exchanged for cash, in whole or in part. No compensation will be provided for any unused portion of a prize, and any unused portion will be forfeited.

• **NOTIFICATION AND REDEMPTION:** The potential winner will be contacted by email or phone. The Contest Administrator will make up to three (3) attempts to contact the selected entrant within seven (7) days of the draw. If the selected entrant does not respond within seventy-two (72) hours of the third contact attempt, or if the contact information provided is incomplete or incorrect, another eligible entrant may be selected by random draw. Before receiving the prize, the potential winner may be required to sign and return a release form within seventy-two (72) hours of receiving it, confirming compliance with these Official Rules and releasing the Contest Administrator and related parties from liability associated with the prize. If confirmed as eligible, the winner may pick up the prize at the nearest CAA Saskatchewan Store.

• **ODDS TO WIN:** The odds of winning depend on the number of eligible entries received before the Contest End Date.

• **PRIVACY:** The Contest Administrator may collect personal information from entrants, including name, telephone number, email address, Saskatchewan residency, and confirmation that the entrant is at least 18 years old, for the purpose of administering the Contest and for market research purposes. This information will not be sold or transferred to third parties except in the following circumstances:

- when required by law;
in limited circumstances disclosed to the entrant at the time the information is collected, including in these Official Rules.
- to the Contest Administrator's agents, service providers, professional advisors, or promotional and marketing agencies, but only as needed to administer the Contest and only for the purposes described in these Official Rules.

• **PUBLICITY:** By accepting the prize, the winner gives the Contest Administrator permission to use their name, likeness, voice, and comments for advertising and promotional purposes in any media, without additional compensation, unless prohibited by law.

• **RESTRICTIONS:** The following actions are prohibited and will result in automatic disqualification: (1) entering under more than one email address; (2) entering more than once; (3) accessing or tampering with the Contest Administrator's systems, source code, or data; (4) using any method that artificially increases the odds of winning; (5) failing to

comply with these Official Rules; or (6) any other action that, in the Contest Administrator's sole discretion, compromises the integrity of the Contest.

- **ANNOUNCEMENT OF WINNER:** The winner will be contacted directly, and the winner's name will be posted on the CAA Saskatchewan website at caask.ca/magazine.

- **GENERAL TERMS AND CONDITIONS:** This Contest is void outside Canada, in the province of Quebec, and wherever prohibited by law, and is subject to all applicable federal, provincial, municipal, and local laws and regulations. By accepting a prize, the winner acknowledges that the Contest Administrator makes no representations or warranties of any kind regarding the prize, including any implied warranty of merchantability or fitness for a particular purpose. By participating in the Contest, each entrant agrees to release and hold harmless the Contest Administrator, its participating retailers or partners, officers, directors, shareholders, agents, parent companies, affiliates, subsidiaries, advertising and promotion agencies, fulfillment agencies, and legal advisors (collectively, the "Released Parties") from any claims, losses, damages, or actions arising from participation in the Contest or the acceptance, possession, or use of any prize, including claims related to personal injury, death, property damage, publicity rights, defamation, or invasion of privacy.

All entries and prize claims become the property of the Contest Administrator and will not be returned. The Released Parties are not responsible for injury or damage to persons or property arising, directly or indirectly, from participation in the Contest or from downloading material from the Contest Administrator's servers or any other website, whether the material was prepared by the Contest Administrator or a third party. The Contest Administrator reserves the right to amend these rules at any time without prior notice.

The Contest Administrator reserves the right to cancel, suspend, or modify the Contest, including ending it before the Contest End Date, if fraud, human error, technical issues, printing errors, network failures, server failures, hardware failures, or any other factor beyond the Contest Administrator's reasonable control affects the integrity or proper administration of the Contest. If this happens, the Contest Administrator may, but is not required to, select a winner at random from among all eligible entries received before the issue occurred.

The Released Parties are not responsible for technical, hardware, software, or telephone failures of any kind; lost or unavailable network connections; or entries, requests, or prize claims that are stolen, illegible, incomplete, misdirected, lost, late, postage-due, damaged, garbled, deleted, or otherwise ineligible.
